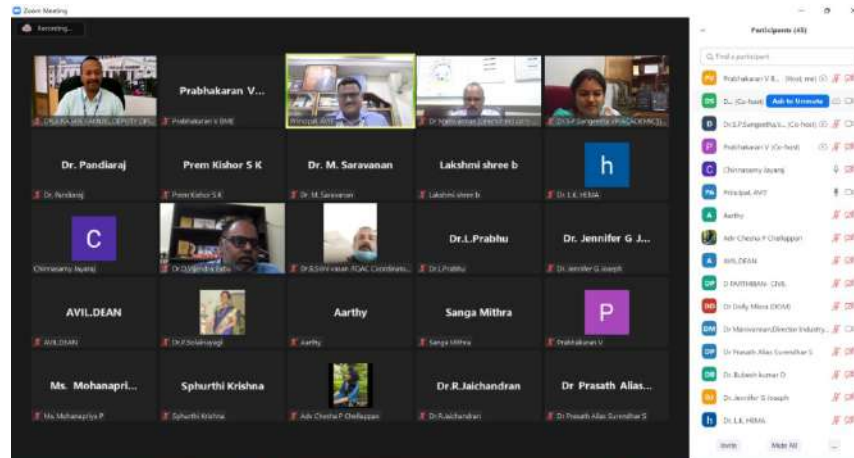

Module 5 Lecture topics were related to Personal-Emotional Development and Counseling. Prof.B.S.Balaganapathy, delivered a thought provoking lecture on Student Diversity and Challenges and responsibility in handling them and the importance of Stress Management. Importance and need for individual and group counselling, Ethical and moral codes of counselling were also discussed.

How to Conduct a Discipline-specific Research, its planning, and writing a research proposal along with various funding opportunities that helps involving students in research was delivered by Dr. D. 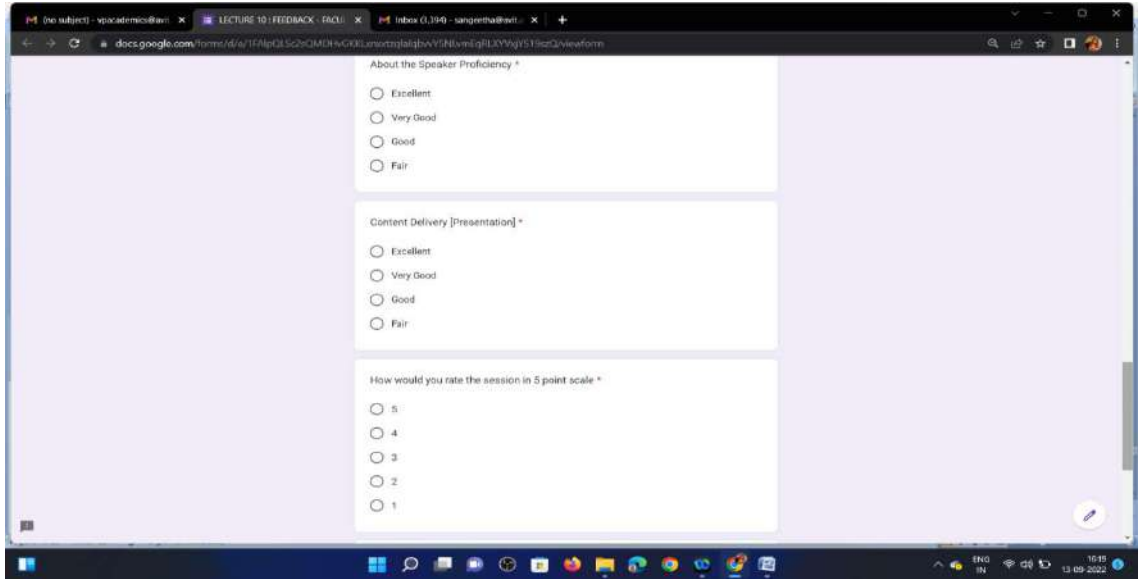

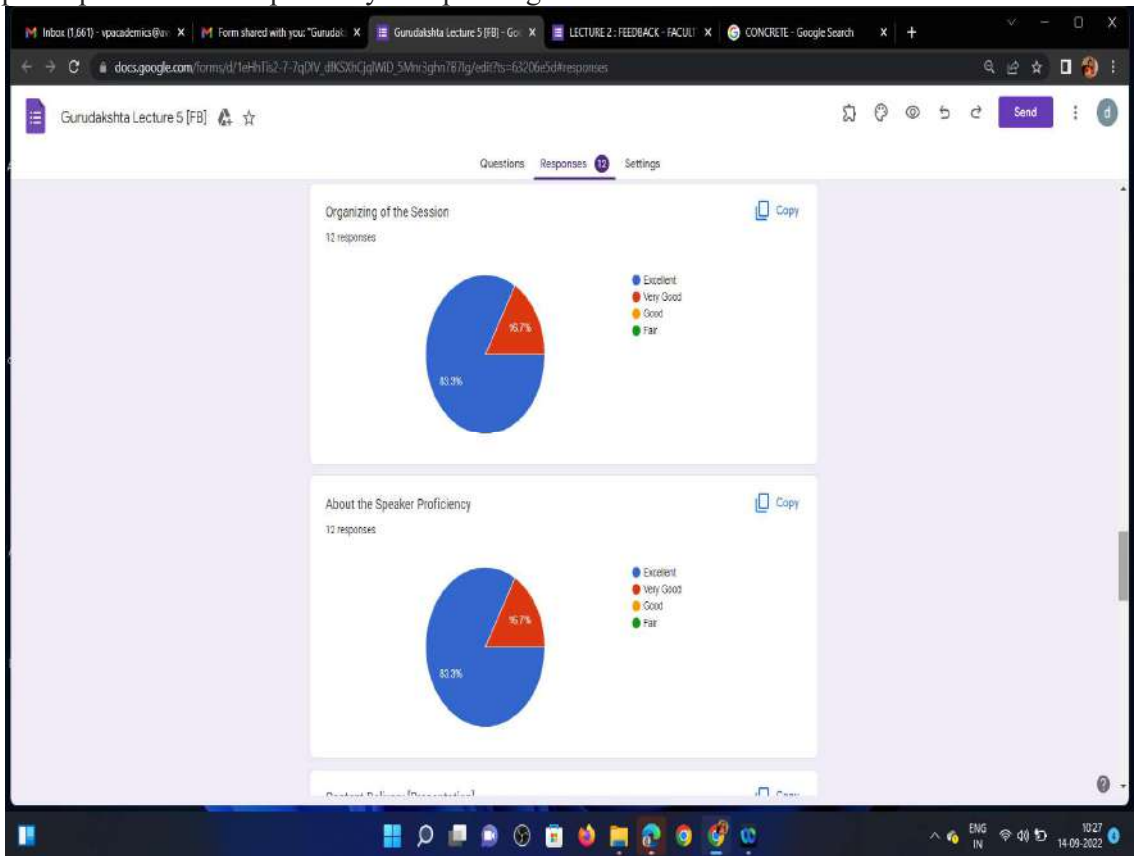

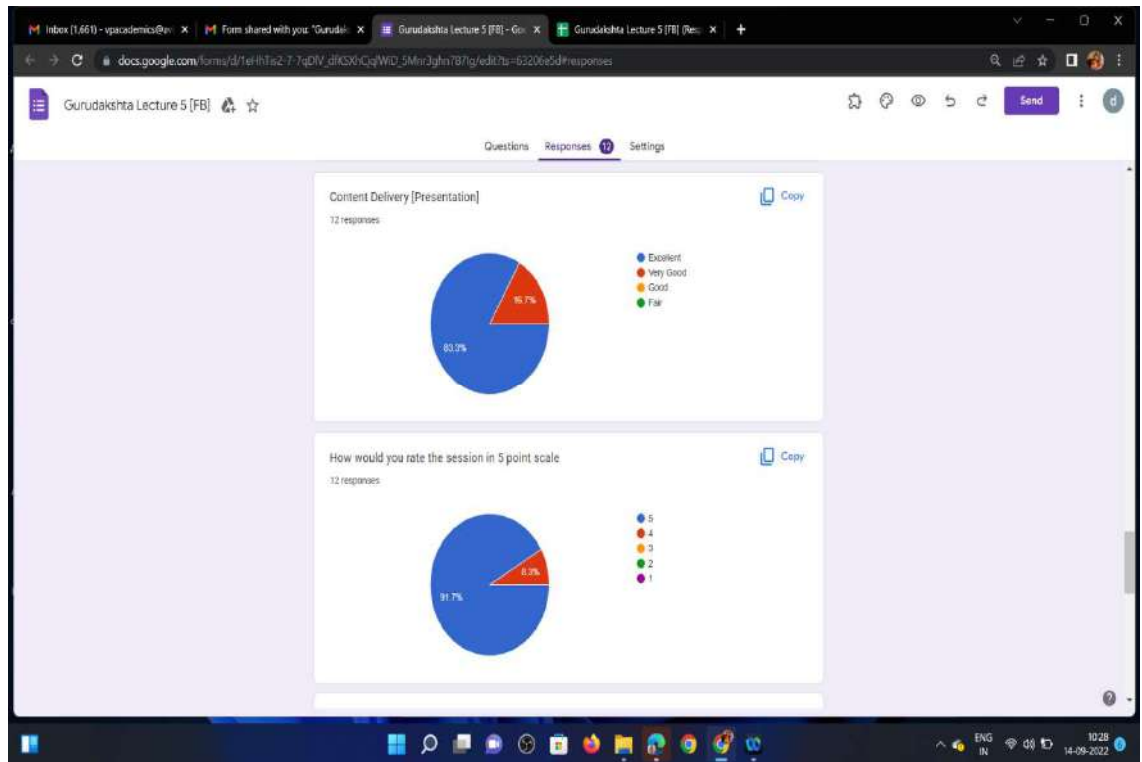
