- An important source of funding, especially for startups
- IP management policy
 - Licensing
- Different types i.e. exclusive, non-exclusive, cross
- Patentee earns a royalty
- Royalty payments from Indian subsidiaries to their overseas parents have risen by nearly 42% over five years
 - Assignment
- Employment agreements (part of normal duties)
- In other cases, the patentee receives a lump sum payment
- Patent Drafting Considerations

IPRs include patents, trademarks, copyrights, trade secrets, and a number of more specialized instruments such as plant patents.

The workshop highlighted on various aspects related to patent for start up

1. IP for startup “The protection of intellectual property should become one of the elements of business strategies”.
2. The Speaker highlighted on the essential of patent filing which includes creation of ideas, earning recognition or financial benefits and interest of the innovators/public.

IP ISSUES FOR A STARTUP

“Startups necessity conducts a prior art search before patent filing to ensure novelty and avoid legal conflicts.”

3. The presentation boosted the prior knowledge on patent search with key words, background search, claim writing and Technology transfer.
4. IP management constitutes one of the most critical topics for a startup’s success
5. Litigation is the most fearful perspective a startup can be confronted with in the IP field
